Achalam Award

Every year the best 10 paintings of the artists will be awarded the "ACHALAM AWARD" which will continue this year also. These awards will be given separately for the student's category (below 18 years) and artist's category (18-35years). The senior artists (above 35years) are not eligible for the competition but they can exhibit their works.

- The artist participating only in the exhibition are supposed to pay an amount of **Rs.200/-** whereas, those willing to participate in competition are supposed to deposit an amount of **Rs.500/-**
- ➤ Only one work per artist will be considered for the exhibition. The charge of Rs.100/- will be collected for each additional paintings.
- All artworks must be the original work of the participant and it must be suitably framed and ready for hanging.
- The entry fee must be sent along with the Artist Application Form. In case of the application not being selected, the entry fee will be refunded. Applicants can remit the amount through Demand Draft.
- ➤ The Exhibitors should send their original Artworks to the following Address:

- ➤ The Gallery will deduct a commission of 20% on any sales and the remaining 80% will be paid to the artist. At the termination of the exhibition, the local artists must take back unsold artwork within 7 working days. For the other national and international artists, the unsold artwork should be collected within 20 working days.
- > The Exhibitors must cover all the costs and risks associated with the transport, display and removal of their artwork. Exhibitors must insure their exhibits against loss, damage, theft, fire or any other risks at their own cost. While the Organizers would employ adequate security and take all precautionary measures, they cannot be held responsible for any loss, theft or damage.
- ➤ The Organizers will publish an official Chitramela 2017 catalogue. It reserves the right to photograph works for its promotional purposes. Photos and Artworks of those artists participating only in competition will be enrolled in the Souvenir. Each Exhibitor will receive a copy of the Chitramela 2017 Souvenir.
- > The maximum size of the works are as given below:
 - Painting- 3 x 4 ft, Printmaking and photography- 2 x 3 ft, Sculpture- 2 x 2 x 3 ft.
 - Through E-mail, jpeg image of resolution not less than 600kb
 - Through Post, Color photograph of size not less than 4" x 6"

Guidelines for exhibiting Sculptures and Photography:

- > Sculptural works need to be of strong construction and, most importantly, not present a risk to public safety. As such, sharp edges and protrusion points and unstable constructions should be avoided. Any glass will need to be zone toughened.
- ➤ Photographs can be edited or have additions as long as they are authentic. However, adoptions of works done by other artists or plagiarized works are not accepted.
- ➤ Photographs with scripts or drawings such as signatures and borders
- Obscene photographs are strictly prohibited.
